#### **BLC Activities Since the agInnovation 2025 Fall Meeting**

**USDA Reorganization Input** – Developed and submitted agInnovation's recommendations on the USDA Reorganization Plan to Secretary Rollins (September 25, 2025). Recommendations were provided “in-person” during a virtual NIFA Stakeholder Input session and in writing. The recommendations reflected BLC's assessment of the proposal's potential implications for agricultural research and the Land-grant University system's partnerships with USDA agencies and scientists.

**USDA NAREEE Advisory Board Engagement** – Met with Dr. Deirdra Chester (September 23, 2025) to better understand the role and responsibilities of the USDA National Agricultural Research, Extension, Education, and Economics (NAREEE) Advisory Board and to explore opportunities to strengthen agInnovation's visibility, engagement, and influence in informing USDA research, education, and Extension policies.

**CGA Representation on BLC** – Matt Hammons (UNL, Assistant VP for External Relations and Director of Federal Relations) joined the BLC as the new representative from the APLU Council on Government Affairs (CGA). Matt also serves as Chair of the CGA Agricultural Appropriations Committee, strengthening coordination between agInnovation and APLU's federal advocacy efforts.

**Washington, D.C. Update Meetings** – Established recurring update sessions (approximately every 4–6 weeks) for all agInnovation members to provide timely briefings on federal budget developments, agency activities, and congressional actions affecting agricultural research. These sessions, led by Elizabeth Stulberg (Lewis-Burke Associates) and BLC's CGA representative, also provide an opportunity for directors to ask questions and discuss emerging policy issues. Attendance has remained consistently strong.

**2026 BLC Work Plan** – Developed a comprehensive work plan to guide committee priorities and activities throughout 2026. Key focus areas include developing the FY2028 federal budget request, supporting the Land-grant University Call to Action, providing ongoing federal policy and Washington, D.C. updates to agInnovation leadership, and exploring an expanded stakeholder engagement role for the BLC.

**Research Facilities Act Program (RFAP) Recommendations** – Responded to NIFA's request for stakeholder input on implementation of the Research Facilities Act Program (RFAP) in February 2026. agInnovation's recommendations were presented during USDA stakeholder webinars and submitted directly to USDA leadership to help inform program implementation. The RFAP NOFO incorporated

several changes suggested by BLC, including inclusion of planning grants, range of award sizes, and eligibility for institutions who received funding from the FY2026 RFAP.

**Develop a DRAFT FY2028 Budget Request for discussion at the BAA Summer Leadership Meeting (July 2026).**

**LGU Roadmap Collaboration** – Expect to partner to advance the LGU Roadmap—particularly in shaping a cohesive budget strategy.
