- 2. Impact Communications (Sara Delheimer and Sarah Lupis)
 - a. Annual Report, First Quarter, Discussions:
 - i. There are better quality reports in NIMSS this year than in the past. Are we missing an opportunities by not creating impact statements for certain projects that have good reports? This is something to keep in mind, as kglobal's priorities (currently water and healthy foods/people) might not always be the same as other stakeholders, i.e. NCCC211 Cover Crops project. Increasing interest in training opportunities. Sara has finite time and resources to create impacts statements. There are many criteria that go into selecting which projects get an impact statement every year; goal is to write about topics that will have the most impact in terms of promoting the LGU system. To that end,

we work closely with our marketing and advocacy experts to focus on priority areas that will provide the most benefit to the 'family' holistically and work to continue federal support.

- ii. There was a discussion regarding presenting the impact reporting workshop to AES versus other groups, costs, etc. Sarah and Sara are extremely careful to screen requests and stay within the project's scope of work when responding to requests for workshops.
