Status of the "single ask request" – Bill Brown, Mike Harrington

The ESCOP Summary was positive for the NC, NE, S and W. The 1890 input, submitted separately, is requesting 2% off the top increase for each 1890 program (Evans Allen research and 1890 Extension, \$4M each). This would address the funding problems that arose with the addition of Central State University. There has been discussion about the level of the request (e.g. \$200 m vs \$300 m). Based on preliminary discussions, Cornerstone feels that the \$200 m figure is realistic. In the event of no increase, there was some concern that other programs could face reductions to support increases for the 1890's.

The BAC met on Tuesday January 17. Over all the feedback was very positive. The BAC recommended Adopting the strategy to the PBD.

All concerns and suggested additional FAQs were submitted to Cornerstone. A new version of the one pager will be available soon. The Ag communicators are ready to review and update the one pager as needed. Next Steps:

- February PBD Meeting: Ratify BAC recommendation
- March 5 8: CARET/AHS

It is clear that there some are way out in front of this with the potential for misinformation to abound. It is crucial that clear communications from the BAC and the Policy Board be forthcoming as soon as possible.

The results of the "Capacity Funds Survey" are not available.
