- Chair's Interim Actions
  - o Gary in touch with Andrea Putman to get involved with Retaking the Field
    - ESCOP would craft a multistate report for Retaking the Field

      - Gary will continue engagement with Andrea Putman
  - o APS-ESS Joint Session
    - Inaugural collaborative session, want to keep up with that moving forward
  - Invited Amrit Bart (ICOP) to the Exec Meeting (Item 4.0) to discuss how ESCOP and ICOP can best interact
- 2.1 Policy Board of Directors
  - Jay Akridge gave a detailed summary of the PBD activities
  - Gary Thompson is the ESCOP Policy Board rep, some points to discuss and report back to PBD:
    - Involvement of B&L committee (outcome of BAC meeting)
    - Joint COPs meeting, Guadalajara 2018
- Jump to 4.0 International Agriculture Section Engagement (Amrit Bart)
  - ESCOP / ICOP want to initiate a discussion on how the groups can interact as National organizations
  - The group introduced themselves to Amrit Bart
  - o Creating "International Scholars / Global Students"
    - What can Experiment Stations do in conjunction with International Programs?
  - o (Amrit takes the floor)
    - ICOP is grappling with a cohesive strategic plan, adjustments to their bylaws
    - Because of alliance with CII and BAA, ICOP is looking at where they fit into this structure

- Advocates for international:
  - Curriculum enhancement
  - Research enhancement
  - Outreach enhancement developing countries, developing missions
- ESCOP Institutions can easily share international efforts
  - How can ICOP interact within the BAA?
  - Should ICOP decide to be a part of the BAA?
- ESCOP funding / research portfolios are broader than "NIFA"
  - Grad education/research portfolios are in lockstep
  - How do we enhance international research activities?
  - ESCOP should limit their scope to Graduate and Research activities
- o (Bill Brown) Tennessee
  - Tennessee has an international program office
  - Often International programs will report to the Administrative Head
  - What are opportunities with USAID, student exchange / research exchange opportunities, NIFA international graduate student training RFA?
  - Faculty are serving adjunct appointments at int'l institutions
  - Grad student training exchange US China
  - Study abroad
- o (Amrit Bart)
  - Recent visit to USAID office
  - Innovation Labs are an exciting graduate research opportunity
- o (Mike Harrington)
  - ESCOP should inventory the international opportunities across its institutions
- o (Gary Thompson)
  - What is the intersection of ESCOP / ICOP? Not yet identified
- o (Rick Rhodes)
  - Foreign ag service grant, monitoring / evaluating USAID programs
    - Send in 'swat teams' of experts
    - Needed a universal translator for the faculty what's the research component?
    - Hard to find faculty with the expertise to rapidly materialize for a USAID request
- o (Amrit Bart)
  - USAID isn't funding as many project
    - We should diversify the sources of our resources
      - Foundations (e.g. Gates foundation)
- o (Adel Shirmohammadi)
  - Are there any continental based or country based programs aligned to focus on specific topic areas?
  - Can OECD (France) be of value to us?
    - UMD has received fellowships from there before
- o (Amrit Bart)

- UGA, Maryland, Auburn Consortium on food safety related topics with Chinese scientists
- o (Joe Colletti)
  - Entrepreneurship / ecosystem
  - Connectivity between entrepreneurship activities, and the relationships with Foundations (e.g. Gates)?
  - Beyond research empowering people with a business acumen to forge joint efforts
- o (Josh Stull, NIFA)
  - Otto Gonzalez should be involved
- o Gary Thompson
  - Potential theme for a joint session what can we do, together, for international programs?
- ICOP is in the early stages and can't commit to much just yet...will take these ideas back to the group for discussion
- No objections to furthering the ESCOP ICOP collaboration
  - Consensus that this is definitely a worthwhile endeavor
- Many thanks to Amrit Bart. Gary/Rick/Amrit will be in touch on a joint session
- 2.2 CMC
  - CMC is suggesting repositioning, to increase our ability to activate our network as a result of the CMP
  - CMC is an ESCOP committee, treated as a standing committee of the BAA, operating somewhere in between
  - Proposal to elevate the CMC to reflect the importance of the work
  - o Positioning paper will be presented to the PBD
    - Recommendation for the CMC to become an adhoc committee of the BAA, with the goal of establishment as a standing committee one year after activation as an adhoc
    - Standing Committee requires 2/3 vote of Directors' membership
      - Challenge is getting participation in that vote
    - Request for BAA to create a funding mechanism for the CMC
      - CMC is currently funded through contributions from ESS/CES/AHS (\$133,333 each)
      - Where will money come from if this is no longer a standing committee of ESCOP?
    - CMC will need to articulate the value of kglobal succinctly, in a way that resonates with ECOP
    - PBD could make this part of the BAA Assessment then there wouldn't be a section assessment, which requires approval
  - ECOP is not questioning the committee, they are questioning kglobal (Consultant on annual contract)
    - kglobal has undergone management / personnel changes, and are different than they were at the onset of the CMC
      - kglobal has pivoted

- Part of the CMP was disjointed from the BAA
- kglobal was trying to develop a national following, to demonstrate the value of Experiment Stations and Cooperative Extension
- CMC is not engaged in Sales...
- With the alignment of the CMP to the BAA priority areas, we've activated the audience involved in the CMP
  - The "one-ask" CTA received a tepid response, but it was the greatest response to date on our engagement with congress
- o Each institution has different restrictions on engaging congressional delegations
- One Director activated their institution's network Bill Brown, Tennessee
  - Tracked activity and engagement to key thought leaders / decision makers
- o How do we operate in the current Washington environment?
  - While retaining the importance of our programs
  - While retaining or growing our levels of funding
  - With one story, one voice
- Two components: Legislative/Budgetary, also how do we communicate with the general public?
- 2.3 Science and Technology
  - o Two subcommittees, with an unclear fit in our ESCOP Rules of Operation
    - Social Sciences
    - National IPM Coordinating Committee
    - Regional EDs have drafted language to change the ESCOP Rules of Operation re: S&T subcommittees
  - o Roadmap
    - NCRA has examined "non-book" approaches to a new Roadmap
    - Will provide mockups for the future
- 2.4 Budget & Legislative Committee
  - Time and Effort Reporting
    - Is it allowable for Extension/Research staff to spend time preparing grant proposals for competitive awards?
      - Any proposal written would be a logical next step to an ongoing research effort
    - What constitutes a full-time employee?
      - For Non-Hourly employees, 40 hours / week constitutes full time
      - "other time" may be used to draft proposals
    - Is there a legislative fix for this?
    - Penn State has time / effort university-wide that won't align with NIFA's time / effort reporting
    - Maryland, same situation campus level VPR finance director got involved with the Ag college finance director
      - They come to meetings on this upset in advance
    - Post-docs concerned they won't be able to write grants, but a faculty can have a 40 hour work week and write grants?

- Faculty 60% state 40% capacity the State is already allocated to the teaching mission
- (Gary Thompson) at the BAC meeting, a motion was made that the ESCOP and ECOP B&L committees would work with Cornerstone and other impacted BAC members, to create a document that would consolidate some of the discretionary lines – "Strategic Realignment"
  - Report back to the BAC by January 19, 2018
  - Cornerstone will provide a straw discussion document
- 2.5 Diversity Catalyst Committee
  - (Informational) since Philadelphia, DCC has drafted rules of operation to clarify the size of the committee, also add a NIFA representative to the committee
    - Bobbie Moore (NIFA) is on board as NIFA representative to the DCC
  - o Proposal National Experiment Station Section Diversity & Inclusion Excellence Award
    - Part of the initial Diversity in Research Leadership Task Force
    - Drafted by Jeff, Rick, Dave, Alton, Brian
    - Influenced by Extension's Excellence in Diversity award
    - Full intention of releasing the inaugural call in early 2018
    - Would require an electronic vote for the \$1,000 award
    - DCC would ratify the award in early December
    - ESCOP is invited to comment...
      - We can afford \$1,000
      - Who does the \$1,000 go to? The institution, or the group directly? up to the group
      - Deadline for comments, December 1 2018 (DCC call 12/7/2018)
- 2.6 National Impact Database
  - o Bill Brown special thanks to the regional ED's; Eric Young, lead, and others
  - o Special thanks to Sarah Lupis (WAAESD) and Faith Peppers (UGA)
  - ECOP participation Karla Trautmann, Ron Brown
  - Focusing on design changes, new look, new platform
  - TAMU thanks for a big contribution
    - Research and Extension provide 25% contributions each
    - Scott Cummings, design lead at TAMU presenting a mockup tomorrow
  - Electronic NIDB meeting scheduled for 11/14
    - Focus on Quality quality is currently varied
      - How do we monitor Quality of statements?
      - Gatekeeper? Appointing a jury?
      - Wide range of types of people who are submitting statements
      - Need for impact training and perhaps consistency of submitters
  - Multistate Impact Database has a template we could adopt for the National Impact Database
  - Analytics are implemented, the level of use of the NIDB is positive
    - Analytics reporting will come with the new site
- 2.7 Joint COPs
  - Scheduled for Guadalajara in 2018

- o Proposal from Mexican Group
  - Mexican group is proposing hosting a Mexican cultural event hosted at 3:15pm on the Monday afternoon, which dictates the evening activities
  - Full day meeting on Tuesday
  - Proposal options for Wednesday
    - 1.) All-day Tequila tour Wednesday
    - 2.) Business meetings with optional Tequila tour Thursday
    - Recommendation for option 2, business meetings Wednesday with optional Tequila tour Thursday
- 2.8 [Other] NRCS Update (Jeff Jacobsen)- ask JEFF for updates
  - Group of directors led by Jeff/Robin had a meeting/conversation and will report back to the committee
  - o Group provided a whitepaper on Soil Health
    - Feedback was not overwhelmingly positive
  - New paper, non-competitive approach, requested Soon.
    - Short timeline to turn around
    - Academic programs, through any training that goes on in the state, would like a database of folks involved in conservation planning
      - See what's available to improve the competency level of these people
    - Training/Development opportunity for NRCS folks
  - Negative sentiment is replicated nationwide
  - o Is this a 'token' program?
  - Next steps? -

- 3.0 Advocacy Update, Cornerstone
  - FY18 appropriations process underway
  - Current CR expires Dec 8
    - Another CR expected to extend until mid-late January
    - Puerto Rico asked for \$90b this morning 11/13
  - o 25m increase to AFRI
  - House larger package of appropriations bills
  - o House more to spend than in FY17
  - Reflected in the NIFA top line
  - o Sustainable Ag, Food outreach, Federal administration
  - o House and Senate need to pass tax reform bill
  - Finding relief for budget control act
  - o CLP is doing well
    - 1/2/3x / week ideas come from Congress for Cornerstone's feedback
    - CLP meeting coming 11/14

- SoAR sent letter, signed by a broad cross-reference of stakeholders, sustainable ag entities, a few institutions
- $\circ$   $\;$  Many entities did not see the letter for the first time until the last second
- Cornerstone supports the BAA's approach
- o Organic, Beginning farmer and rancher does not have funding beyond this farm bill
