- 5. Cornerstone report given by Maggie Earle
  - a. The <u>APLU Unified Request for NIFA Funding</u> one-pager is set and was distributed yesterday morning via email and included with a sample email to use.

- 6. NIFA update Paula Geiger, Josh Stull
  - a. Not on call, no report given.
  - b. Vernie indicated that Josh has left NIFA. ACTION: Chris will remove him from our BLC member list and Jeff will follow up on a replacement. (Both done, 2/26)
- 7. ECOP report Jon Boren
  - a. Not on call, none given.
  - b. ACTION: Jeff will follow up with Jon Boren and ECOP leadership regarding the BLC calls and ECOP representation. (Done, 2/26)
- 8. Discussion of the Upcoming BAC Meeting Agenda at CARET/AHS Ernie
  - a. Ernie described the upcoming BAC agenda to the group, which will include:
    - i. Welcome and Overview.
    - ii. Legislative Climate Update by CGA.
    - iii. One hour allotted on the agenda for "Determining Advocacy Strategies."
      - 1. Process for allocation of new funds or reduction of existing funds and how system will approach that.
      - 2. Responding to Sign-on Requests or Ag-related Initiatives.
    - iv. Developing Multi-year Goals and Strategies.
    - v. Next Steps for BAC.
    - b. Comments from the BLC membership:
      - i. Jeff indicated that both BAC and CLP will be more active, so ESCOP needs to be thinking about different topics and angles, as we are doing on this call today.
      - ii. Ernie asked the group to consider also advocacy decisions when one or two groups focus in on one line only (e.g. SoAR, AGree on only AFRI, etc.)
      - iii. Rick mentioned the 7 core priority areas of APLU, which then translate 9 different lines, and then we add 5 more areas under the 7 core priorities. This action makes it seem as if we actually do not have clear priorities. What's the best way to seek assistance so that we clearly define our priority areas?
      - iv. Jon Wraith indicated that his priorities haven't changed in 10 years, but the diversity within the family perhaps is stymieing us.
      - v. Jeff: Could we perhaps focus only on 1-3 priorities at a time as an alternative approach? Jon Wraith agreed and is supportive bumping up 1-3 lines, such as the 1890s, while keeping others stable. Rick agreed.
      - vi. ACTION: Please forward additional thoughts on to Ernie and Jeff before this Sunday, so they can share with the BAC.
    - vii. All are welcome to attend the BAC meeting; Ernie is our ESCOP voting member.
