- NEERA 2104: Northeast Region Technical Committee on Integrated Pest Management

- Meetings piggybacked with AC meeting
- Turnover in region: retirements mainly; some new people; some restructuring
- One purpose for some working groups is to maintain body of knowledge: tree fruit, in particular


#### **NEIPM CENTER FUNDING**

- 2018 2022 USDA NIFA, CPPM funds: \$4,000,000 total, NCE through 8/31/2023
- USDA NIFA: Stop Pests IPM in Affordable Housing, through 2021, flow through from US HUD; process changed to direct contract with US HUD
- USDA NIFA SCRI: Management of the brown marmorated stink bug in US specialty crops, NCSU lead, 2016 2022, \$941,874
- USDA NIFA: An Undergraduate IPM training program for the South and NE regions, UMD lead, 2019, \$36,752 total for Center
- USDA NIFA SCRI on SLF: Penn State/Julie Urban lead, 2019, \$792,038 total for Cornell (Center lead, some Subawards)
- US HUD: Promoting IPM Management in Affordable Housing, 2021, \$667,373 total (includes a subaward and some contracts)
- 2022 2026 USDA NIFA, CPPM funds: \$4,000,000 total

- Others not awarded in 2022: SCRI proposals (BMSB/Oregon lead; earworm in sweet corn/UMD lead; certification/Red Tomato lead



- Effective program but funding is declining


## NE IPM Center Partnership Awards by Type (2018-22)




NE IPM Center Grant Funding Goes to Institutions Across the Region (2018-2022)


#### ROUND UP SURVEY

- Targeted survey of the 2,692 recipients on the Center contact email list
- 85 respondents: 33% Extension, 16% educators, 8% researchers, 8% federal employees, 7% university faculty, 9% county, state, or tribal government employees, 5% environmentalists, 5% pest management professionals, 3% growers, 1% from an NGO, and 6% 'other'
- 68% stated that the IPM News and Events Roundup is either very or extremely useful, 32% stated that it is moderately or somewhat useful, and no one stated that it was not useful.
- 52% were very or extremely likely to increase IPM implementation and 40% were somewhat or moderately likely to increase IPM implementation.
- Center has received over 30 emails expressing positive feedback and testimonials.
- Surendra Dara, Cooperative Extension Advisor, UCal Ag and Natural Resources, said, "If there is an award for the best email or newsletter, this should be the one... There is always interesting/useful information in your news roundup."




#### STOP PESTS EVALUATION DATA 2016-2021
