General meeting minutes:

- Discussion on SSSc Rules of Operation
 - o Changes:
 - Top of Pg. 2 First sentence underneath *Organization and Function* change "may" to "will" to read "The SSSc will meet in person once....."
 - Top of Pg. 2 Second paragraph, second sentence underneath Organization and Function – add "two weeks prior" and remove "in advance" to the sentence to read "Meeting agendas and support materials will be provided two weeks prior to any meetings."

- Top of Pg. 2 Last sentence underneath Organization and Function "The work groups will be responsible to the S&T." should be changed to "The work groups will report back to SSSc committee."
- Bottom of Pg. 2 Add this sentence to the end of the first paragraph underneath Officers, Executive Committee and Liaisons – "The Secretary will be responsible for taking minutes during any officially called meetings."
- Bottom of Pg. 2 First sentence underneath *Quorum* remove "in advance" and add "two weeks prior" to read "For purposes of doing business, a quorum shall consist of a simple majority of the duly constituted members at any officially called meeting for which written notice is sent two weeks prior to the meeting."
- Bottom of Pg. 2 First sentence underneath Amendments remove "in advance" and add "two weeks prior" to read "These operating guidelines may be amended at any business meeting of SSSc provided the proposed amendment has been sent to all members two weeks prior to the meeting..."
- How much latitude do we have with this committee?
 - (Mike Retallick) It has been my experience in the past that the committee (primarily) governs itself
- Discussion regarding the number of seats on the SSSc committee
 - Currently have 36 spots on committee, have 20 of these spots filled, have 15 of the 20 spots in attendance at the meeting
 - Hard to keep up with such a large committee
 - o Why so many seats?
 - Having representation from all geographies, contexts
 - o How to gain more participation or ideas on committee members?
 - Perhaps send out request (to serve on committees) to regional organization leaders
 - Should we be recruiting members for content and not necessarily geographic regions?
 - Will looking for specific content expertise help on projects?
 - 2 comments (Corrine)
 - Disciplines are important, as far as expertise
 - Need to know what the driving issues are right now and how does each discipline tackle them.
 - o Do we want to modify the size of the committee? The At Large positions?
 - University of Wisconsin rural soc group would like to become involved on the committee
 - Recommendation to hold on the committee numbers (think through until next meeting)
 - Disciplines are important, regions are important what the ultimate number is not specified

- Can we put a statement in that says diverse (geographically, discipline) membership as opposed to a specific number required?
- O Quorum simple majority (50%) of those who attend the meeting
- Voting electronically when changes are made
- Election of Secretary/Vice-Chair
 - o Nominations? Kevan Lamm self nominated
 - Kevan Lamm was elected as Secretary/Vice-Chair (2023-2025)
- Fall Meeting time?
 - o In Washington, DC
 - September or October
 - o Reach out to APLU and determine a good date (probably a Thursday/Friday)
