#### Q1 2024 NIMSS Updates:

#### **Performance and Technology Upgrades:**

- Upgraded to Laravel 10: This is a major, behind-the-scenes upgrade that has not only made our site faster, but also streamlines the development of new features
- New search engine (Meilisearch): Users can expect quicker and more accurate search results, improving overall site navigation
- New media storage engine (Spatie): Our media storage now consumes less space and retrieves content faster

#### **User experience improvements:**

- Non-Technical Summary and RSA Enhancements: We've added the non-technical summary, for RSAs we've added 'Send Reminder' button, RSA project correspondence
- Improved pagination: Navigation through project search and advanced search is now smoother, thanks to better pagination
- Enhanced Project Management: Added clearer project status indicators (namely for when a project is Approved but hasn't yet started) and updates the email sent when project is approved
- Enhanced Account Management: Reworked password reset process to align with modern security practices
- Email and Export Improvements: Moved 'email' to its own column in multiple directories and added links to project pages on CSV exports to make data more accessible

#### **Security Enhancements**

- Secure external packages: Versions of external packages have been updated, resulting in better security for the site at large
- Honeypot for bot submission reduction: We've added a honeypot mechanism to the user interest form to reduce unwanted bot submissions

#### **Additional Upgrades**

Added regular data backups to ensure data integrity and reliability
