- Introductions, Review of Agenda

**Presenter**: Jocelyn Richgels and Keith Mueller (Virtual). *The Rural Policy Research Institute (RUPRI)* 

- Limited updates at the moment, focus on reconciliation bill
- Developed Comprehensive Rural Wealth framework (based on Community Capitals Framework)
  - o Collaborating with private insurance partner to implement
  - o Have, or planned, to implement in Indiana, Iowa, and Michigan
- Three major focus areas:
  - Health rural health value
  - Policy analysis and input
  - Research Center RUPRIHealth.org
- Previously hosted a summit on rural health
  - New vision: community focus, message matters, build from assets, address gaps (public health, workforce, payment reform, long term care)
  - Actions:
    - Financial and payment reform, sustainable funding models
    - Strengthening the workforce
    - Enhance leadership and collaboration
    - Improve technology and data (e.g. broadband)
- Other notes:
  - Housing (HUD Funding)
  - Center for local and state policy
  - Medicaid is very important to rural
  - o Farm Bill has a large impact on rural

**Presenter**: Wendy Naus, Executive Director COSSA. *The Consortium of Social Science Associations (COSSA)* 

- Advocacy organization
- Currently federal funding is under a continuing resolution expires March 14
- COSSA.org has analysis of all Executive Orders available
- Focus areas: Science funding, conducting research, scientific workforce, place of science in society
- Recommendations to engage in personal communications with policy makers

**Presenter**: Wendy Fink, APLU Associate Vice President Food, Agriculture, and Natural Resources

- Very dynamic situation, policy and directive shifts happening rapidly
  - In general, it is important to relay specific impacts from efforts and policy changes through professional societies
  - Recommendation is to work through government relations/affairs offices as appropriate – preparation is important
- Land-grant.org available to provide APLU information and requests
  - o Some indication of both House and Senate to support Farm Bill in 2026
- The National Land-Grant Impacts Database is a powerful way to demonstrate the value of social science. A recommendation is to coordinate with local contacts to ensure social science is represented in impacts which are sent to APLU from the institution.
- https://ag-ngine.cals.ufl.edu/ program to address recruitment within higher education and agriculture.
  - According to USDA employment outlook report there were approximately 58K roles available and 38K graduates.
  - A new outlook report is upcoming, expectation is for the need gap to expand

## **Review & Discussion of 2024 Action Items**

- Review and approval of Minutes
  - o Moved to approve by Mike Retallick, second by Bryan Hains
  - Motion passed, minutes approved
- The committee will need to elect a new S&T Committee representative
- NSF CASA-Bio grant the committee did not participate in the public comment process
- Previous suggestion to engage with successful grant writers Emily Buck indicated an interest in continuing to pursue this action if it was of interest to the committee
- General discussion
  - Suggestion to focus on "translational research" processes to describe typical social science efforts. For example, connecting potential users with new technology early in the process.
  - Suggestion to share findings from the ESCOP meeting with local institutions as well as professional associations – perhaps in the form of a position brief, not a full white paper

- Suggestion to proactively communicate the value of social science
- Open discussion regarding the goal and need for the committee
  - Important to develop stories to better capture the impact and importance of social science work
  - Challenges with access issues need to interface with Extension

**Presenter**: Laura Wood (Virtual). *National Coalition for Food and Agricultural Research (NCFAR)*.

- Advocacy organization (focus on Congress)
- Focus across REE attempt to increase funding (Build Back Better program)
- Food is the third largest sector of GDP
- A current challenge is the speed at which change is occurring proactive vs. reactionary
- When communicating with policy makers, impacts and good examples are powerful
- Mixed insights regarding continuing resolution and mid-March effects
- Reminder that all politics are local and it is important to know local representative

# **Presenter**: Joshua Stull, USDA Stakeholder Affairs Officer

- RFAs currently under review for compliance with Executive Orders, expect to be rereleased when aligned
- Secretary of Agriculture is in place, Chief of Staff also in place
- Offer to assist facilitating tours of the USDA Whitten Building in Washington D.C.

# Presenter: Dr. Jeanette Thurston, Executive Director, agInnovation North Central Region

- Current grants from USDA NIFA are under review, there may be the need to edit objectives and/or plans of work
- The 10 year organization road map has been drafted, under discussion with other stakeholders. For example, Extension is working to develop additional pillars for the broader framework. (https://www.aginnovation.info/research-roadmap-2025)
- Top focus areas:
  - o Research facilities act, associated with the Farm Bill
  - Capacity programs
- Continue to monitor administration priorities

- LGU and Community engagement highly connected
- Focus on Talent Innovation Place overlap
- Studies have shown a decline in perceptions regarding the value of higher education in general
- Developing the perception of an engaged institution
- 1999 Kellogg Report still used extensively
- Based on metrics there are strong indications of commitment to engagement
- June 29 July 1: CECE Conference, New York (Cornell University Roosevelt Island)
- In general, the more touchpoints with communities the better

**Presenter**: Dr. Marisol Morales, *Executive Director, Carnegie Elective Classifications & Assistant Vice President American Council on Education* 

 Opportunity to connect knowledge and resources of institutions with the needs of communities

- It is important to build partnerships thoughtfully including needs and limitations Important to think about policies and structures to honor the time and effort of communities as well as faculty, staff, etc.
- Seek to ensure alignment between institutional mission and actions
- Creating a co-learning space is important
- Suggestions to improve:
  - Faculty development is key
  - o Institutions should provide resources for faculty to learn
  - Make trained facilitators available to assist move away from one faculty contact with communities to institutional contact with communities
  - Should develop an appreciation for engaged scholarship
  - Dedicated offices at institutions can help provide support and serve as single point of contact for communities and university personnel
  - Onboarding for community partners is important
- Classification process:
  - Evolves from cycle to cycle intended to be completed by practitioners at the institution
  - "the process is the prize" focus on process not outcome
  - Will begin to provide individualized feedback
