Key Takeaways

- **RFA Details:** Undersecretary Hutchins confirmed key RFA details: a one-project-per-institution limit, eligibility for planning grants and land acquisition, and potential match waivers for smaller institutions.
- **BLC Strategy:** The BLC will convert its existing RFA recommendation document into a formal submission for the Feb 12 deadline and will also make verbal comments at the Feb 3 listening session.
- **Timeline Pressure:** The \$125M must be encumbered by Sep 30, creating a compressed timeline. This makes "shovel-ready" projects and a broad distribution of smaller grants more likely.
- **Science Agenda:** The BLC's roadmap should align with USDA's 5 priorities: farm profitability, biosecurity, human health, land intensification, and precision nutrition.

RFA Update from Undersecretary Hutchins

- Alton reported on a mid-December meeting with Undersecretary Scott Hutchins and his team.
- **RFA Details:**
 - **Submission Limit:** One project per institution at a time.
 - **Rationale:** This is a major concern for the BLC, as it could create internal competition at universities with multiple colleges involved in food/ag.
 - **Eligibility:** Includes planning grants, remodeling, and land acquisition.

- **Match Requirement:** Hutchins will encourage the Secretary to waive or reduce the 1:1 match for smaller institutions (1862s, 1890s, 1994s). Non-cash matches and deferred match payments (due before project end) are also being considered.
- **Science Agenda:**
 - Hutchins affirmed USDA's 5 R&D priorities: farm profitability, biosecurity, human health, land intensification, and precision nutrition.
 - **Action:** The BLC's roadmap should explicitly align with these priorities.
- **Investment:** Hutchins supports a "significant investment" in food/ag research but did not provide a specific figure.

BLC Strategy for RFA Response

- The BLC will convert its existing RFA recommendation document into a formal submission for the Feb 12 deadline.
- **Key Recommendations:**
 - **Grant Cap:** Propose a reasonable upper limit for individual grants to ensure broad distribution.
 - **"Shovel-Ready" Projects:** Recommend prioritizing these for the first year due to the compressed timeline.
 - **Geographic & Institutional Diversity:** Reiterate the need for broad distribution across states and institution types.
- **Verbal Comments:** The BLC will also make verbal comments at the Feb 3 listening session to reinforce its written submission.

Chronological Summary

[Update on meeting with USDA Undersecretary @ 12:15](#)

Alton provided an update on his recent meeting with USDA Undersecretary Scott Hutchins and other USDA officials. Key points included:

- Hutchins indicated the upcoming RFA (now called a "NOFO") will allow for land acquisition and facility remodeling, in addition to research projects
- Hutchins said institutions will be limited to submitting one project at a time, but may be able to submit additional projects after the first is completed
- Hutchins mentioned the possibility of planning grants and consideration of waivers or reduced match requirements for smaller institutions like 1890s and 1994s
- Hutchins reiterated the 5 priority research areas outlined by the Secretary, and encouraged aligning the community's roadmap with those priorities

The group discussed their plans to provide written comments and potentially verbal feedback during the upcoming RFA/NOFO listening session:

- There was agreement to submit the existing document developed by the committee, reformatting it from a Q&A to a set of recommendations
- Participants raised additional questions to potentially include, such as whether there will be an upper limit on individual project funding amounts
- The group acknowledged the tight timeline, with written comments due by February 12th, and discussed the need to quickly gather any final input from the broader community
